**Firms Meeting Responsible Contractor Standards:**

1. Are fully licensed and bonded
2. Have had no wage/hour violations for the past 3 years.
3. Provide OSHA 10-hour safety training
4. Participate in an ERISA or joint labor-management training program (e.g. certified apprenticeship program).
5. Pay prevailing wages and offer health insurance.
6. Provide all benefits of employment to their workforce (including social security, workers comp, and unemployment insurance)
7. Comply with all other federal and state regulations.
8. Have no history of violating this policy in previous public contracts
