### MEMBERSHIP

**Membership Eligibility** – Paid membership in the WMCA shall be open to all organized construction industry contractors and contractor associations, organized trade associations & councils and union locals as well as those organizations who seek affiliation with the WMCA and agree to their goals.

**Dues** - The WMCA is entirely funded from voluntary dues. The Alliance has no set yearly dues. Rather, dues have been structured according to an organization's financial capability and willingness to contribute. January 1 – December 31 is the WMCA's fiscal year.
